"The METROPOLIS. THE TERRITORY OF CHILDHOOD".

Organizers of the forum: Administration of urban district Ufa city of the Republic of Bashkortostan, Management of the trusteeship and guardianship of Ufa, the Advisory Council on health and physical education students under the State Duma Committee for education and science, Charitable Foundation of social orphanhood prevention (Moscow), the Foundation of social, cultural and economic development of Ufa "Public Fund of city development", Bashkir Institute of social technologies.

The objectives of the forum:

- Create conditions for discussion of the most relevant protection problems of rights and legitimate interests of children left without parental care, and exchange of experience in the field of prevention of social orphanhood.
- Generalisation and distribution of regional and municipal innovative technologies to prevent social orphanhood, development of family forms for orphans and children left without parental care.

The main issues for discussion:

- Regional system of prevention family problems and support families with children, effective technologies and practices that ensure the advancement of families in difficult life situations.
- Preventing abandonment of newborn children and children during the first years of life.
- Introduction of effective forms of family placement of older children and children with disabilities – students of organizations for orphans and children left without parental care.



- Lowering the secondary abandonment of foster children through the improvement of professional competence and quality of service professionals working in the field of family placement of children deprived of parental care.
- Prevention of violence and abuse in the family and school.
- Prevention of aggressive and auto aggressive behavior in children and adolescents.
- Prevention of suicidal behavior in minors.
- The use of health technologies in the work with students of educational institutions.
- Interdepartmental cooperation in the organization of social support of families with children at the level of the municipality.
- Formation and development of the market of services for families and children in the city. Involvement in the provision of services to children and families of socially responsible business and socially oriented non-profit organizations.
- The use of mediation technology as an effective mechanism of formation of parent-child relationships in adoptive families.
- Providing a safe and comfortable family environment of the child, the priority of the child's upbringing in his own family, the formation of family values, children, and responsible parenthood.
- Priority problems in the sphere of protection of children from crime.
- To build professional communication experts and practitioners from the regions to exchange experiences, discuss approaches and technologies work in the field of protection of children's rights.

To participate in the forum are invited: executives and specialists of Managements, Departments of family and youth policy, social protection, health, education, bodies of guardianship and guardianship; the administration and specialists of the centers for families and children, centres for psychological-pedagogical, medical and social assistance centers of rehabilitation and correction, health and social offices, clinics, hospitals, rehabilitation centers, centers for social protection of population, scientific institutions, specialists of state and municipal services, non-governmental organizations and business structures, representatives of media, public organizations and all interested persons.
